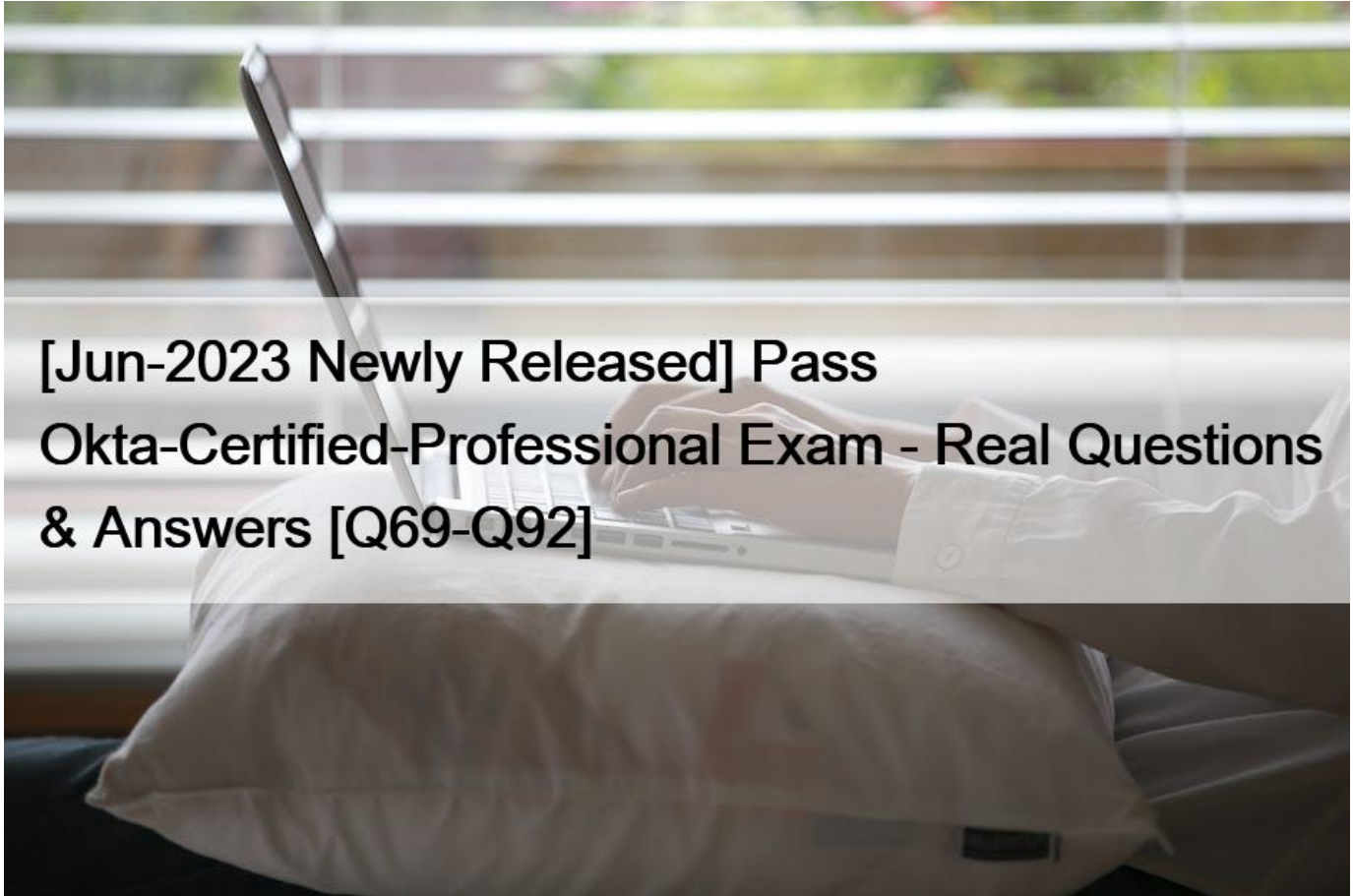

By combining self-service password resets with SSO, not only can organizations reduce the number of required passwords (a security benefit, as well as end-user convenience) but users are able to access all their applications through a single password reset.

2. Receive either an email or an SMS message The user has the option to receive either an email or an SMS message containing a password reset code. With both options, the user still has to answer a security question to verify identity before they are allowed to reset their password. This security question and answer is created when users enroll in Okta MFA.

3. Enter a new passwordThe newly created password can still impose the same password policies such as character length, number of special characters required, etc., ensuring a consistent password policy throughout the organization.
